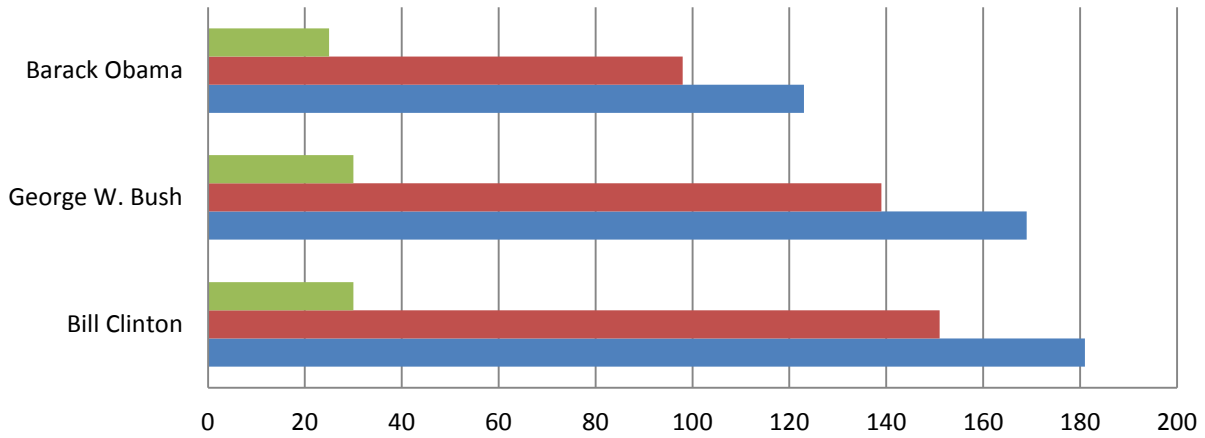


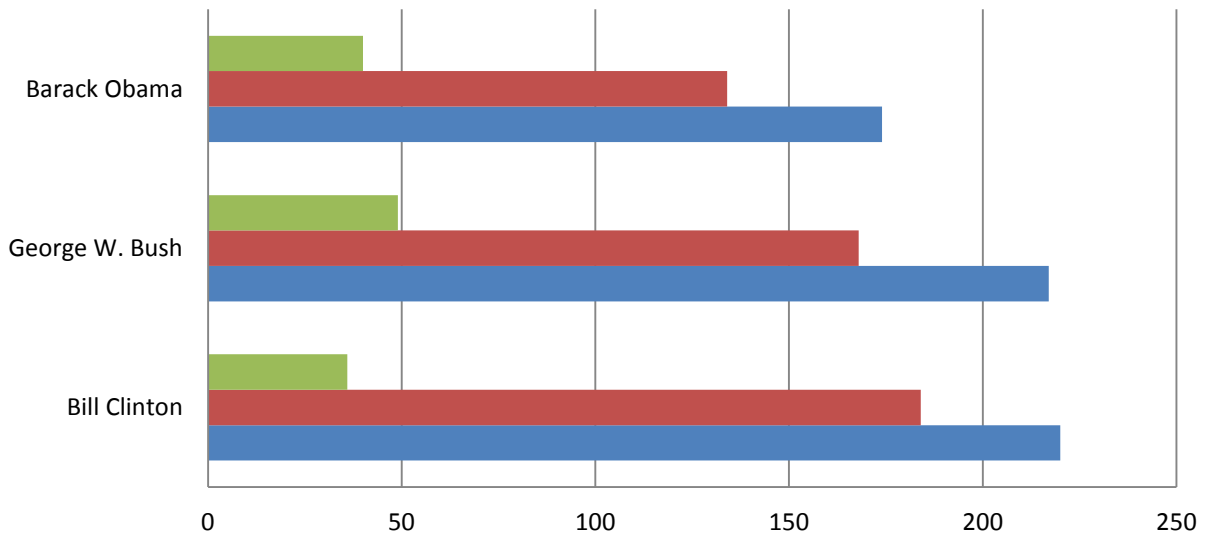

## Federal Judicial Confirmations (1/25/12)



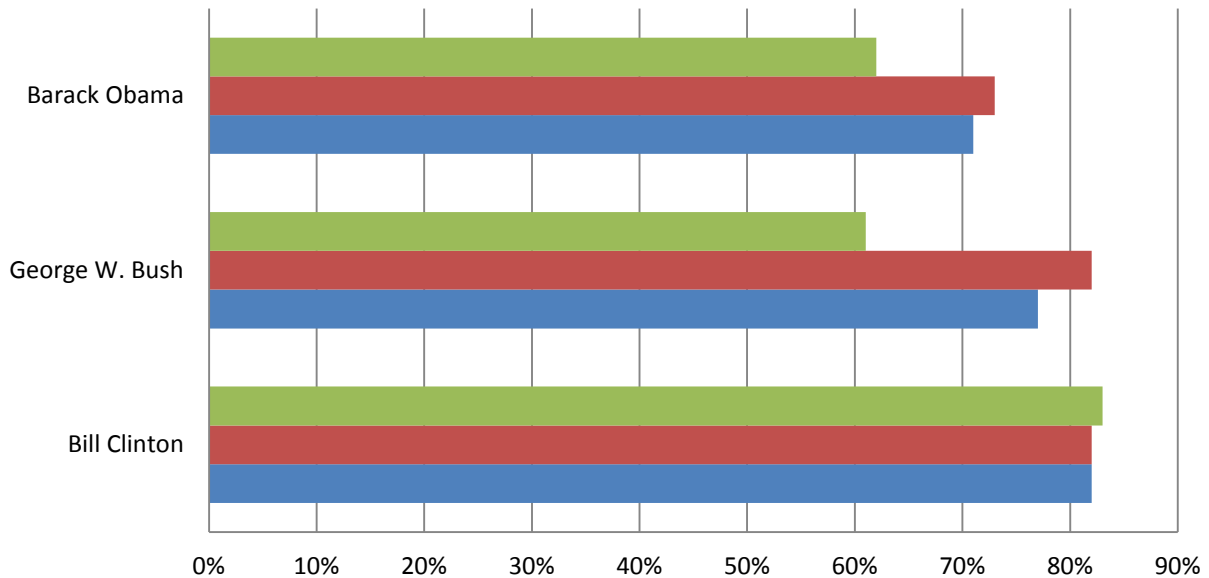
