NAME OF PANEL: ACS Chicago: The Chicago Police Department Consent Decree -- Where Do Things Stand?

BRIEF DESCRIPTION:

The U.S. Attorney General launched a broad civil rights investigation in 2015 into the CPD's policing practices. The U.S. Department of Justice (DOJ) released the results of its investigation in January 2017, finding a longstanding, pervasive "pattern or practice" of civil rights abuses by the CPD. In August 2017, the Office of the Illinois Attorney General (OAG) sued the City in federal court, seeking a Consent Decree that would address DOJ's findings and recommendations. The OAG then sought input from community members and Chicago police officers and negotiated the Consent Decree with the City. In March 2018, the Parties to the Consent Decree, the OAG and the City, also entered into a Memorandum of Agreement with "certain community organizations that have established a broad-based community coalition ('Coalition') committed to monitoring, enforcing, and educating the community about" the Consent Decree. Judge Dow approved and signed the Consent Decree on January 31, 2019. The Consent Decree requires actions by the CPD and many other City entities.
