Jan	<ul style="list-style-type: none"> Organize a day of service for Martin Luther King Jr. Day (see ACS Volunteer Opportunities here). National Day of Racial Healing. Use ACS's Program Guides here. 1/19: Anniversary of Glasser v. United States (holding that the exclusion of women from a jury pool violates the Sixth Amendment). Host an event on Constitutional interpretation. Join or renew your ACS National membership. Elect board members.
Feb	<ul style="list-style-type: none"> Black History Month. Consider connecting with your local National Bar Association chapter to co-sponsor programming elevating Black voices and experiences, and the issues identified in this program guide on Combatting Anti-Black Racism Through Law and Policy. Event on First Amendment: ACS First Amendment program guide here. Host discussions on Court reform, including a code of ethics for Supreme Court Justices. Host an event on How to Write an Op-Ed or other ways to engage with the media.
March	<ul style="list-style-type: none"> Women's History Month. Check out ACS's program guide on Marking the Centennial of the Nineteenth Amendment (including the Equal Rights Amendment). 3/26: Equal Pay Day. Host an event on gender disparities in pay within the legal profession 3/3: Anniversary of Worcester v. Georgia (laying the foundation for tribal sovereignty). 3/6: Anniversary of Dred Scott v. Sanford. Plan programming on Truth, Racial Healing, and Transformation. 3/26: Anniversary of Baker v. Carr (redistricting of state legislative districts is not a political question, and therefore justiciable). Plan an event on gerrymandering. How to Become a Judicial Clerk or How to Become a Judge. Host a local, state, or federal judge. Host an event on progressive federalism (host the local mayor or member of city council, explore the role of State AGs in protecting & advancing civil rights, explore the work of state courts).
April	<ul style="list-style-type: none"> Arab American Heritage Month. Consider connecting with your local Arab American Bar Association chapter to co-sponsor programming to elevate Arab, Middle Eastern, and Muslim voices and experiences, and issues impacting these communities. Sexual Assault and Harassment Awareness Month. 4/2: Anniversary of Massachusetts v. EPA. Plan an event on environmental protections. Consider inviting an attorney from your State AG office. 4/22: Earth Day. Host an event on the relationship between the law, climate crisis, and environmental racism. Include an international law or comparative law perspective. Continue road shows to recruit 3Ls at law schools, speak at an end-of-year happy hour for students, and encourage students to join a lawyer chapter wherever they go. 4/29: Anniversary of Louisiana v. Callais (limiting the use of Section 2 of the Voting Rights Act and narrowing the ability to consider race in determining electoral districts). Consider planning programming on Voting Rights (see program guide here).
May	<ul style="list-style-type: none"> Asian Pacific Heritage Month. Consider connecting with your local National Asian Pacific American Bar Association to co-sponsor programming elevating AAPI voices and experiences. 5/1: Law Day: Considering hosting a Constitution in the Classroom lesson. 5/1: International Workers' Day. Host an event on labor, unions, and labor law. 5/17: Anniversary of Brown v. Board of Education (ordering the desegregation of public schools and renouncing the doctrine of "separate but equal"). See program guides on Racial Equality and Truth, Racial Healing, and Transformation. 5/31: Anniversary of the Tulsa Race Massacre.

Consider connecting with your local National LGBTQ+ Bar Association Affiliate to co-sponsor programming elevating LGBTQ+ voices, issues, and experiences. • ACS National Convention • 6/11: Anniversary of Tuan Anh Nguyen v. Immigration and Naturalization Service (the different requirements for a child's acquisition of citizenship depending upon whether the citizen parent is the mother or the father, is consistent with the equal protection guarantee embedded in the Due Process Clause of the Fifth Amendment). • 6/12: Anniversary of Loving v. Virginia (striking down state bans on interracial marriage). • 6/13: Anniversary of Miranda v. Arizona (requiring that criminal suspects being interrogated by the police be informed of their right to consult with an attorney and to remain silent). • 6/24: Anniversary of Dobbs v. Jackson Women's Health Organization (overturning the Constitutional right to an abortion).
